OVERVIEW

The DVS2P is a 2-port DVI splitter, which can send one DVI video source signal to two connected DVI monitors for identical displays.

The DVS2P is plug-and-play, meaning it is ready for immediate use upon connection to input-output devices and a power supply. Simply connect the splitter to a DVI source and two monitors, then power on the unit: your DVI video will display on both monitors in stunning Full HD (1920x1200 @ 60Hz). The DVS2P excels at creating dual-screen displays in a variety of settings and applications. Set up a DVS2P at bench testing facilities, data servers for better visualization of information, help desks for unified displays, and more!





INSTALLATION

- 1. Turn off the power of all devices (computer, monitors and splitter).
- 2. Connect the video source's DVI output port to the splitter DVI input port using standard DVI cable.
- 3. Connect the video source's DVI output port to the splitter DVI output port.
- 4. Plug the power supply into the DVI splitter.
- 5. Plug the power supply into the wall outlet or power bar. Check to see if the power LED light is active on the front of the DVI splitter.
- 6. Turn on the displays.
- 7. Turn on the video source.



OPERATION FOR CASCADE

If you need to add more monitors, you need to attach an addition splitter box.

Connect a DVI male/male extension cable between a Video Out port or the primary splitter (the splitter connected to the computer) and the Video In port on the cascaded splitter.

NOTE: Even though you can cascade the splitter, the image might become unstable if you cascade too many tiers of splitters.

TROUBLESHOOTING

No Power

- Make sure that the power adapter is securely connected to the power connector of the unit.
- Check the output voltage of the power supply and make sure that the voltage value is around 5VDC.
- Replace the power supply.

No Video

- Check if all the video cables are connected properly.
- Connect the computer directly to the monitor to verify that your monitor and computer are functioning properly.
- Try replacing the video cable.
- Restart the computers.
